A tract of land situated in the Southwest Quarter of the Southeast Quarter (SW₁ SE₁) of Section 26, Township 2 North, Range 6 E. W. M., described as follows:

Beginning at a point 899.4 feet north and 250 feet west of the southwest corner of the Southeast Quarter of the Southeast Quarter (SE₁ SE₁) of Section 26, Township 2 North, Range 6 E. W. M. (said point being the southwest corner of the N. E. C. 
