A parcel of land in Lot 2 of Lethlean Short Plat No. 2 described as follows: Beginning at a point on the west line of Section 17, said point lying S 0° 57' 20" E 1,301.53 feet from the northwest corner of Section 17; thence N 76° 52' 12" E 211.22 feet; thence N 53° 12" E 5.21 feet to the initial point of the tract hereby described; thence N 53° 12' E 63.79 feet; thence easterly following an arc to the right 217.91 feet, said arc having a radius of 329.20 feet and whose long chord bears N 72° 9' 50" E 213.95 feet; Thence S 88° 52' 30" E 124.59 feet; thence S 1° 17' 50" W 20.00 feet; thence N 88° 52' 30" W 124.53 feet; thence following an arc to the left 202.63 feet, said arc having a radius of 272.9 feet and whose long chord bears S 69° 51' 20" W 198.01 feet; thence S 48° 35' W 18.17 feet; thence following an arc to the right 68.04 feet, said arc having a radius of 318.30 feet and whose long chord bears S 54° 42' 30" W 67.91 feet; thence N 0° 57' 20" E 35.70 feet to the initial point.

Containing a total acreage of 0.22 acres and being a net additional right of way area of 0.03 acres more or less.
