

## DECLARATION OF HOMESTEAD

KNOW ALL MEN BY THESE PRESENTS: That I, ELLEN LYNNE BOWIE,  
do hereby certify and declare as follows:

That I, ELLEN LYNNE BOWIE, am a divorced person and that I reside on the premises hereinafter described, which premises were acquired during my marriage to THOM J. BOWIE, and at the time of acquisition and subsequent thereto said premises have been my separate property.

## II.

That I, the undersigned, hereby declare that I am the head of the household, residing with my family, consisting of my three children, and that I hereby claim the premises hereinafter described as a homestead.

### III.

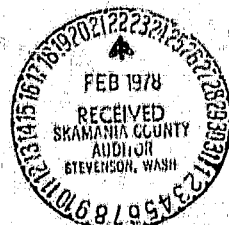
That I estimate the reasonable cash value of the premises belonging to myself as my separate property to be in the sum of less than \$20,000.00, including all appurtenances thereon situated, exclusive of any mortgages, mechanic's or materialmen's liens.

#### IV.
