

DEED OF PERSONAL REPRESENTATIVE

The Grantor, George B. Malarkey, as personal representative of the ancillary Washington estate of Herbert Malarkey, aka James H. Malarkey, deceased, does hereby bargain, sell and convey unto the Grantee, The United States National Bank of Oregon, as executor and personal representative of the domiciliary Oregon estate of Herbert Malarkey, aka James H. Malarkey, deceased, and trustee for distributorship, the estate's right and interest of said deceased at the time of his death and all right, title and interest that the said estate by operation of law or otherwise may have thereafter acquired in that certain real property situated in the County of Skamania, State of Washington, described as follows, to wit:

The West 1/2 of the Northeast 1/4 and the Northeast 1/4 of the Northwest 1/4 of Section 20, Township 2 North, Range 5 East of the Willamette Meridian.

SUBJECT TO a reservation of 50% of mineral rights in said premises for a period of 20 years, reserved by Vera M. Borin in instrument dated January 15, 1967 and recorded January 18, 1967 in Book 56 of Deeds at page 500, under Auditor's File No. 68047

ALSO SUBJECT TO the right of the State of Washington in and to that portion of said premises, if any, lying in the bed of the North Fork of the Washougal River, if said River is navigable.

SUBJECT TO all other easements, reservations and restrictions of record

Herbert Malarkey, aka James H. Malarkey, died testate on July 29, 1975, and George B. Malarkey is the duly appointed, qualified and acting personal representative, with will annexed, of his Washington estate which is probate cause No. 23928 in the Superior Court for Clark County, Washington. This deed is given pursuant to the Order Approving Final Account entered in said cause.
