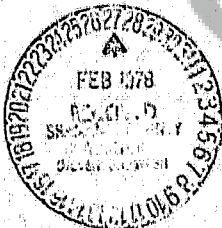

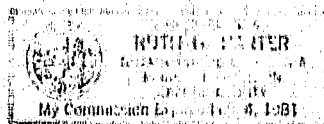

LAST WILL AND TESTAMENT

OF

ROBERT V. UHLIK

I, ROBERT V. UHLIK, a resident of Orange County, California, declare this to be my last Will and revoke all former Wills and Codicils.

FIRST: I direct my Executrix to pay my just debts, last illness and funeral expenses.

SECOND: I declare that I am married and that my wife's name is ELIZABETH V. UHLIK. We have one child, our daughter, PATRICIA ANN HAVIKEN, and we have one grandson, MICHAEL HAVIKEN.

THIRD: I give, devise and bequeath the residue of my estate, real and personal, wherever situated, to my wife, ELIZABETH V. UHLIK. If she predeceases me, then I give, devise and bequeath said residue to my daughter, PATRICIA ANN HAVIKEN, and if she also predeceases me, then to my grandson, MICHAEL HAVIKEN. In the event neither my wife nor my daughter nor my grandson survive me, then I give, devise and bequeath one-half thereof to MAXINE BABEL, VIRGINIA PUDDICOMBE and VICTOR UHLIK, or the survivors or survivor thereof, and the remaining one-half to the SHRINERS CRIPPLED CHILDRENS' HOSPITALS.

FOURTH: I appoint as Executrix of this Will my wife, ELIZABETH V. UHLIK, to act without bond. If she predeceases me or declines or is unable to act, then I appoint my daughter, PATRICIA ANN HAVIKEN as Executrix, to act

without bond. If they both predecease me or decline or are unable to act, then I appoint SECURITY PACIFIC NATIONAL BANK, a national banking association, as Executor. I authorize my Executrix or Executor to sell property of my estate, subject to such confirmation of Court as may be required by law.
