

DECLARATION OF HOMESTEAD

KNOW ALL MEN BY THESE PRESENTS, that CLYDE N. REDMANN and ALICE M. REDMANN, husband and wife, of Cook, Skamania County, Washington, have declared and do declare:

1. That I, CLYDE N. REDMANN, am the head of a family, that I am married, that my wife's name is ALICE M. REDMANN.
2. That we are now residing as a family on premises located in Cook, Skamania County, Washington, and hereinafter more particularly described as:

Beginning at the northeast corner of the Southwest Quarter of the Southwest Quarter of the Southwest Quarter (SW 1/4 SW 1/4 SW 1/4) of Section 11, Township 3 North, Range 9 E.W.M.; thence west 20 rods to the initial point of the tract hereby described; thence south 9 rods; thence west 11 rods; thence north 11 rods; thence east 11 rods to the initial point.

Beginning at the initial point above said; thence west 11 rods; thence north 23.5 feet to the existing fence; thence in a southeasterly direction following said fence line a distance of 182.4 feet to a point 1.5 feet north of the initial point; thence south 5.5 feet to the initial point;

TOGETHER WITH all water rights appurtenant thereto.

3. The actual cash value of the premises is the sum of \$25,000.00.
4. We have selected the above mentioned premises as a homestead, and do hereby select and claim the same as and for a homestead for our family, and exempt from execution as such.

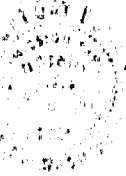
