A right of way as required for the County Road known and designated Cook-Underwood Road (County Road No. 93041) located in Section 11, Township 3 North, Range 9 East W.M. in Skamania County, Washington.

All that portion of the following described parcel lying within the Northeast quarter of the Southwest quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 11, Township 3 North, Range 9 East W.M.

PARCEL DESCRIPTION

A strip of land 60 feet in width, being 30 feet on the right and 30 feet on the left of the following described centerline from Engineers Station 239 + 71 to Station 262 + 00.

Also, a strip of land 80 feet in width lying 30 feet on the right and 50 feet on the left from Station 262 + 00 to Station 264 + 00.

Also, a strip of land 30 feet in width, beginning at Engineers Station 239 + 71, thence N 88° 50' 12" W to the West line of the Northeast quarter of the Southwest quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 11, Township 3 North, Range 9 East W.M.; thence North 30 feet; thence S 88° 50' 12" E to a point 30 feet distant North from Engineers Station 239 + 71; thence South 30 feet to point of beginning.

Station 258 + 90.30; thence N 0° 16' 49" E 10°.04 feet to P.C. 259 + 97.34; thence along a 500 foot radius curve to the right 541.88 feet to P.T. Station 265 + 39.22; thence N 62° 22' 29" E 302.17 feet to P.C. 268 + 41.39; thence along a 1,000 foot radius curve to the left 8.82 feet to P.T. Station 268 + 50.21; thence N 61° 52' 00" E 145.58 feet to P.T. Station 269 + 95.80; thence S 28° 7' 52" E 30.92 feet to P.C. Station 270 + 26.72; thence along a 100 foot radius curve to the left 136.25 feet to P.T. Station 271 + 62.97; thence N 73° 48' 11" E 133.49 feet to P.C. Station 272 + 96.46; thence along a 550 foot curve to the right 177.31 feet to P.T.
