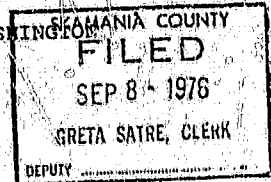

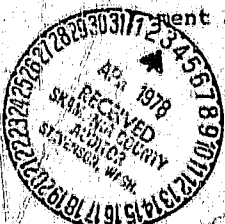
## IV

subject to the indebtedness thereon to Riverview Savings and Loan and subject to a lien in favor of respondent in the amount of \$7,500.00, said lien to be satisfied in the event petitioner sells said property."

That except as hereinabove amended, said Property Settlement Agreement shall be and remain in full force and effect.

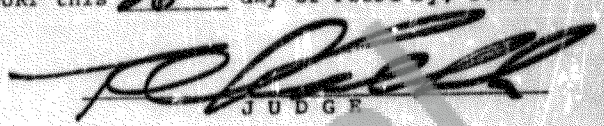
