hereby conveys and quitclaims to the City of North Bonneville, a municipal corporation in the State of Washington,

all of its right, title and interest in the following described real property situated in the County of Skamania, State of Washington, to wit:

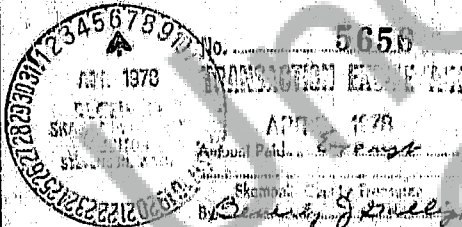

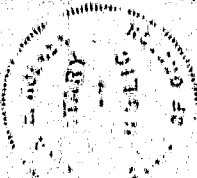



