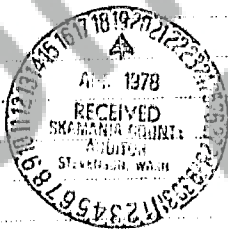
I, the undersigned, being the OWNER of the property herein described, do, in consideration of the benefits and advantages to accrue to by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way sixty five feet in width over and across the following described piece or parcel of land, to-wit:

The South half of the Southeast Quarter (SE 1/4) of Section 34, Township 2 North, Range 5 East W.M. in Skamania County, Washington more particularly:

A 65 foot wide and 65 feet width, lying 35 feet on the left and 30 feet on the right of the following described line.

Beginning at Engineer Station 42 + 24.25, said point lying on the South line of Section 34, N 89° 29' 41" W 1,312.13 feet from the Southeast corner of said Section 34; thence N 4° 25' 39" E 125.75 feet.

Consisting of a total acreage of 0.10 acres.
