It is further understood and agreed that Grantors may erect or maintain fences across said road, provided adequate gates of not less than 16 feet in width are installed, which may be kept locked, provided the UNITED STATES OF AMERICA is also permitted to install its own lock thereon.

Access road, Mc-R-R-AR-31, Parcel 7, may be used for ingress and egress to and from the Bonneville Power Administration's chary-Ross transmission line and to and from any existing or future transmission lines which have been or may be constructed adjacent or nearly adjacent thereto.
