State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA, State of Washington:

A right of way a required for the County Road known and designated Skye Road (County Road No. 11080), Located in the Southwest Quarter of the Southeast Quarter (SW 1/4, SE 1/4) of Section 19, Township 2 North, Range 5 East Willamette Meridian in Skamania County, Washington.

MORE PARTICULARLY

That portion of the Southwest Quarter of the Southeast Quarter (SW 1/4, SE 1/4) of Section 19, Township 2 North, Range 5 East Willamette Meridian, lying southerly of the centerline of the Skye Road, No. 11080, as existing in June 1977, and northerly of a line drawn as follows: 30 feet distant left (Southerly) from the following described line:

Beginning at Engineer's Station 108+94.25, said point lying N88°25'04"W 1250.27 feet from the Brass Monument marking the southeast corner of Section 19, Township 2 North, Range 5 East, Willamette Meridian; Thence N67°13'40"W 565.97 feet to P.I. Sta 114+60.22; Thence N67°08' 53"W 489.78 feet to E.O.P. Sta. 119+50.
