

COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT, made and entered into this 10th day of May, 1978, by and between JIMMY L. BRYAN and SHARON L. BRYAN, husband and wife, of Underwood, Skamania County, Washington, pursuant to the provisions of Section 25.14.020, Revised Code of Washington, providing for agreements between husband and wife for the fixing of the status and disposition of community property to take effect upon the death of either,

WITNESSETH:

That for and in consideration of the mutual love and affection that each of the parties has for the other, and in consideration of the mutual benefits to be derived by the parties hereto, it is hereby agreed, covenanted and remised as follows:

I.

That all of the property of whatever nature or kind or description, whether real or personal or mixed, and wheresoever situated, now owned or hereafter acquired by them or either of them, shall be considered and hereby declared to be the community property of the parties. That the real estate now so owned hereby is situated in the County of Skamania, State of Washington, and particularly described as follows:

The South 279 feet of the west 1/4 foot of the Northwest Quarter of the Southeast Quarter (WT SQ) of Section 15, Township 3 North, Range 10 E., U. S. A.


II.

That it is agreed by and between the parties hereto that this indenture entitled Community Property Agreement shall have the effect in addition of covering any form of personal property and fixing the status and disposition thereof as community property to all stocks, bonds, household goods, or any other personal property of any nature, character and description.

COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT made and entered into this 10th day of May, 1978, by and between JIMMY L. BRYAN and SISTER L. BRYAN, husband and wife, of Underwood, Skamania County, Washington, pursuant to the provisions of Section 21.14.030 Revised Code of Washington, providing for agreements between husband and wife, for the fixing of the status and disposition of community property to take effect upon the death of either.

WITNESSETH:

That for and in consideration of the mutual love and affection that each of the parties has for the other, and in consideration of the mutual benefits to be derived by the parties hereto, it is hereby agreed, covenanted and remanded as follows:

I.

That all of the property of whatever nature owned or described, whether real or personal or mixed, and whereever situated, now owned or hereafter acquired by them or either of them, shall be considered and is hereby declared to be, the community property of the parties. That the real estate now or conveyed hereby is situated in the County of Skamania, State of Washington, and particularly described as follows:

The South 208 feet of the west 111 feet of the Northwest Quarter of the Southeast Quarter ($\frac{1}{4} \times \frac{1}{4}$) of Section 15, Township 3 North, Range 10 E. W. M.

II.

That it is agreed by and between the parties hereto that this instrument entitled Community Property Agreement shall have the effect in addition of covering any form of personal property and fixing the status and disposition thereof as community property to all stocks, bonds, household goods, or any other personal property of any nature, character and description.

III.

That it is hereby covenanted and agreed that upon the death of either of the parties hereto, title to all the community property as above defined shall immediately vest in fee simple in the survivor of them.
