## DEDICATION DEED

GRANTOR(S) Leverett G. Richards and Virginia A. Richards, husband & wife,for and in consideration of the sum of Ten Dollars and other valuable considerations(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general publicwelfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA, State of Washington:

A right of way as required for the County Road known and designated Skye Road (County Road No. 11080), located in the Southwest quarter of the Southeast quarter (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section 19, Township 2 North, Range 5 East Willamette Meridian in Skamania County, Washington.

## MORE PARTICULARLY:

That portion of the Southwest quarter of the Southeast Quarter (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section 19, Township 2 North, Range 5 East Willamette Meridian, lying southerly of the centerline of the Skye Road and westerly of Pohl Road (County Road No. 11160) as existing in June 1977, and northerly of a line drawn as follows: 30 feet distant left (Southerly) from the following described line:

Beginning at Engineer's Station 108 + 94.25, said point lying N 88° 25' 04" W 1,250.27 feet from the Brass Monument marking the southeast corner of Section 19, Township 2 North, Range 5 East, Willamette Meridian; Thence N 67° 13' 40" W 565.97 feet to P.I. Station 114 + 60.22; Thence N 67° 08' 53" W 489.78 feet to E.O.P. Station 119 + 50. 849

Containing a total acreage of 0.17 acres and being a net additional right-of-way of 0.04 acres more or less.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA

County and its successor or successors for the use of the public forever.
