(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
welfare, to by these present grant, convey and dedicate to SKAMANIA County,
State of Washington, for the use of the public as a county road and appurtenances the following de-
scribed real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known and designated Marks
Road, County Road No. 22310 located in the Southeast quarter of the
Northeast quarter (SE 1/4 NE 1/4) of Section 35, Township 3 North,
Range 7 East W.M. in Skamania County, Washington.

MORE PARTICULARLY:

That parcel of land lying Easterly from the "Loop" County Road,
Westerly from the East line of Section 35 and Southerly of a line
drawn as follows: Beginning at a point on the East line of Section
35, said point lying N 1° 18' 00" E., 1028.23 feet from the East
quarter corner of said Section 35; Thence S 82° 00' 00" W 70 feet
more or less to the East line of Loop Road.
