

# NIGHT OF WAY EASEMENT

THE GRANTOR(S) Merlin Fink and Donna Fink, Husband and Wife

for good and valuable consideration, the receipt of which is hereby acknowledged, hereby grant, warrant and convey to PUBLIC UTILITY DISTRICT NO. 1 OF SKAMANIA COUNTY, WASHINGTON, a municipal corporation, and to its successors and sub-lessee or assigns, the right to enter upon the lands of the Grantor(s) situated in the County of Skamania, State of Washington, and more particularly described by the following easement: A strip of land ten feet (10') wide beginning at the existing power pole, approximately 100' west of Love Road and continuing in a northerly direction, on the following description. Beginning at a point on easterly right-of-way of county road known as Laycock Road, at its intersection with north boundary line of NW $\frac{1}{4}$  of Section 15, Township 3 North, Range 10 East, Willamette Meridian, said point being 530 feet east of northwest corner of section 15, above Township and Range; thence southerly along easterly right-of-way line of said county road to south boundary line of NW $\frac{1}{4}$  of Section 15, said Township and Range, thence east along south boundary line of NW $\frac{1}{4}$  of Section 15, said Township and Range, 1692 feet more or less, thence north 808 feet along west boundary line of a 15 acre tract situated in southeast corner of said northwest quarter; thence north along east boundary line of said NW $\frac{1}{4}$  to northeast corner of said NW $\frac{1}{4}$  of Section 15; thence west along north boundary line of said NW $\frac{1}{4}$ , 2111 feet to point of beginning (excepting a 10 acre tract located on NE $\frac{1}{4}$  of said NW $\frac{1}{4}$ ). The above described parcel contains 93 acres more or less.

To construct, operate and maintain over and under the above described lands, and the streets, roads or highways abutting the said lands, an underground electric transmission or distribution line or system, including wires and conduits, with all convenient or necessary surface mounted appurtenances (and to include riser poles and transformer poles when required) and to cut and trim trees and shrubbery that may interfere with or endanger the operation and maintenance of said line or system, and to license, permit or otherwise agree to the joint use or occupancy of said line or system by other person, firm or corporation for telephone or television purposes.

The grantor(s) agree(s) that all poles, wires or other facilities installed upon or under the above described lands at the Grantor's expense shall remain the property of the Grantor, and that the Grantee shall have the right of ingress and egress over the adjacent lands of the Grantor(s) for the purpose of exercising the rights hereby granted.

All rights hereunder shall cease when the Grantee, its successors and sub-lessee or assigns abandons or removes said line or system.


