

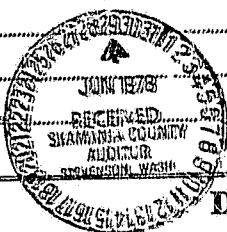

DEDICATION DEED

GRANTOR(S) Theodore A. Madhux and Donna L. Madhux, husband & wife

for and in consideration of the sum of Ten Dollars and other valuable considerations
 (\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to Shumana County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of Shumana State of Washington:

A right of way for the County Road known and designated Marks Road,
 County Road Number 22310 located in the Southwest quarter of the Northwest
 quarter (SW 1/4 NW 1/4) of Section 36, Township 3 North, Range 7 East W.M.
 in Shumana County, Washington.

MORE PARTICULARLY:

That portion of Lot 2 of the Ignaz Wachter Subdivision according to
 official plat thereof lying westerly of the intersection of the northerly
 right of way line of Bonneville Power Administration's Bonneville-Coulee
 Transmission Line and the south line of said Lot 2 and lying within a
 strip of land 40 feet in width, said strip lying 15 feet north and 25 feet
 south of the following described line:

Beginning at a point on the West line of Section 36, Township 3 North,
 Range 7 East W.M., said point lying S 1° 18' 09" E 1,000 feet from the
 brass monument marking the west quarter corner of said Section 36; thence
 N 82° 00' 00" E 39.60 feet; thence S 87° 35' 36" E 134.75 feet to
 Engineers Station 2 + 30.
