

## DEDICATION DEED

GRANTOR(S) Theodore A. Mackay and Danya L. Mackay, husband & wife, for and in consideration of the sum of Ten Dollars and other valuable considerations (\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to Skamania County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of Skamania, State of Washington:

A right of way for the County Road known and designated Marks Road, County Road Number 222310 located in the Southwest quarter of the Northwest quarter (SW 1/4 NW 1/4) of Section 36, Township 3 North, Range 7 East W.M. in Skamania County, Washington.

## MORE PARTICULARLY:

That portion of Lot 2 of the Ignaz Wichter Subdivision according to official plat thereof lying westerly of the intersection of the northerly right of way line of Bonneville Power Administration's Bonneville-Coulee Transmission Line and the south line of said Lot 2 and lying within a strip of land 40 feet in width, said strip lying 15 feet north and 25 feet south of the following described lines:

Beginning at a point on the West line of Section 36, Township 3 North, Range 7 East W.M., said point lying N  $1^{\circ} 18' 09''$  E 1,070.4 feet from the brass monument marking the west quarter corner of said Section 36; thence N  $82^{\circ} 00' 00''$  E 30.60 feet; thence S  $87^{\circ} 35' 34''$  E 154.5 feet to 5954 Engineers Station 2 + 90.
