A right of way as required for the County Road known and designated Skye Road (County Road No. 11030), located in the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 29, Township 2 North, Range 5 East, Willamette Meridian in Skamania County, Washington.

MORE PARTICULARLY

That portion of the following described right of way located in the North 438 feet of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 29, and lying westerly of the centerline of "Skye" Road as located in June 1976.

CENTERLINE DESCRIPTION

Beginning at Engineer's Station P.C. 58+10.80, said point lying S 51°23'56"E 1120.39 feet from the West Quarter (W $\frac{1}{4}$ ) corner of Section 29, Township 2 North, Range 5 East, Willamette Meridian and said point being the P.C. of a 300 foot radius curve to the right whose long chord bears N 9°00'30"E; Thence following said curve 296.69 feet through a central angle of 56°35'50" to P.T. Station 61+07.49; Thence N 39°20'25"E 127.52 feet to Equation Station 62+35.01 back equals 62+36.36 ahead, being the P.C. of a 250 foot radius curve to the left; Thence following said curve 314.26 feet through a central angle of 72°01'25" to P.T. Station 62+50.62; Thence N34°41'00"W 459.76 feet.

RIGHT OF WAY DESCRIPTION

All that land in the North 438 feet of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 29, lying westerly of the centerline of Skye Road as existing in June 1976 and Easterly of a line drawn as follows: Parallel to and forty (40) feet distant left of above described centerline from Station 60+00 to Station 62+50; Thence parallel to and 45 feet distant left of Station 62+00; Thence parallel to and forty-five (45) feet distant left of said centerline from Station 63+00 to the North line of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 29.

Containing a total area of 0.67 acres and being a net additional right of way of 0.36 acres more or less.
