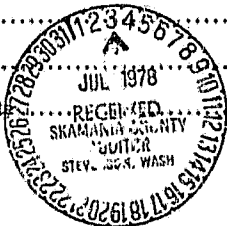

conveys and quit claims to Skamania County

the following described real estate, situated in the County of Skamania State of Washington, together with all after acquired title of the grantor(s) therein:

A right of way for the County Road known and designated Marks Road, County Road Number 22310 located in the Southwest quarter of the Northwest quarter (SW 1/4 NW 1/4) of Section 36, Township 3 North, Range 7 East W.M. in Skamania County, Washington.

MORE PARTICULARLY:

That portion of Lot 2 of the Ignaz Wachter Subdivision according to the official plat thereof deeded to John L. Vassallo and Deloris L. Vassallo, husband and wife by deed dated December 27, 1972 and recorded at page 340, of Book 64 of Deed in the Office of The Skamania County Auditor, Stevenson, Washington and lying within a strip of land 40 feet in width, said strip lying 15 feet north and 25 feet south of the following described line:

Beginning at a point on the West line of Section 36, Township 3 North, Range 7 E.W.M., said point lying N 1° 18' 03" E 1,007.96 feet from the brass monument marking the west quarter corner of said Section 36; thence N 82° 00' 00" E 30.60 feet; thence S 87° 35' 36" E 164.15 feet to engineers station 2+90.

Also that land included within the circumference of a circle having a radius of 40 feet; the center of which lies 25 feet right from station 2+90.
