A right-of-way for the reconstruction of the County Road known and designated Big Buck Creek Road, County Road No. 33750, located in Government Lots 2 and 3, Section 2, Township 3 North, Range 10 East, W.M. in Skamania County, Washington, and in the South one half (S $\frac{1}{2}$) of Section 35, Township 4 North, Range 10 East, W.M. in Klickitat County, Washington.

CENTERLINE DESCRIPTION

Beginning at a brass Indian allotment monument marking the North Quarter Corner of Section 2, Township 3 North, Range 10 East, W.M.; thence S $22^{\circ} 58' 28''$ W, 85.90 feet to Engineers Station 0 + 00, beginning of project; thence N $30^{\circ} 37' 55''$ E, 59.74 feet to P.C. Station 0 + 59.74, being the P.C. of a 75 foot radius curve to the right; thence following said curve through a central angle of $88^{\circ} 30' 00''$, 115.85 feet; thence S $60^{\circ} 52' 05''$ E, 38.85 feet to P.C. Station 2 + 14.43, being the P.C. of a 200 foot radius curve to the left; thence following said curve through a central angle of $11^{\circ} 35' 00''$, 40.43 feet; thence S $72^{\circ} 27' 05''$ E, 81.1 feet to P.C. Station 3 + 36.75, being the P.C. of a 200 foot radius curve to the left; thence following said curve through a central angle of $6^{\circ} 46' 09''$, 23.63 feet; thence S $79^{\circ} 13' 54''$ E, 156.64 feet to P.C. Station 3 + 17.02, being the P.C. of a 100 foot radius curve to the left; thence following said curve through a central angle of $39^{\circ} 23' 16''$, 68.74 feet; thence N $61^{\circ} 22' 50''$ E, 14.24 feet to Station 6 + 00, end of project; said station being S $81^{\circ} 12' 40''$ E, 508.85 feet from the North Quarter Corner of Section 2, Township 3 North, Range 10 East, W.M.

RIGHT-OF-WAY DESCRIPTION

All that portion of Government Lot 3, Section 2, Township 3 North, Range 10 East, W.M. in Skamania County, Washington lying within the following described parcel, said parcel being a strip of land 45 feet in width, lying 20 feet on the left and 25 feet on the right of the above described centerline from Engineers Station 0 + 00 to Station 1 + 00.

Containing a Total of 0.06 acres, being a net additional right-of-way of 0.03 acres, more or less.

Also that portion of said Government Lot 3 lying easterly of the above Right of Way and Northerly of the Road known as Master Peak Road.
