that portion of the Northeast quarter of the Northwest quarter and the East half of the East
half of the Northwest quarter of the Northwest quarter of Section 8, Township 1 North, Range
5 East of the Willamette Meridian, lying Westerly of County Road No. 1004 (designated as the
Belle Center Road), described as follows:

Beginning at a point on the West line of the East half of the East half of the Northwest quarter
