EASEMENT

THIS AGREEMENT, made and entered into this 14 day of December, by and between LONGVIEW FIBRE COMPANY, a Delaware corporation, herein the "Lungview Fibre," and STATE OF WASHINGTON, acting by and through the Department CT Executi Resources, herein called "State," WITNESSETH:

Longvil's Fibre for and in consideration of the grant hereinafter made by State, hereby grants and conveys to State, its successors and assigns, a permanent cuscant upon, ovely and along rights of way sixty (60) feet in width, over and sarabs the lands in Skamania and Cowlitz Counties, Washington, described on the exteched "Exhibit A," being thirty (30) feet on each side of the centerline of a toat or roads located approximately as shown in red on the attached "Exhibit B."

Subject as to said lands to all matters of public record.

B. State, for and in consideration of the grant hereinabove made, hereby excess and conveys to Longview Fibre, its successors and assigns, a permanent experient upon, over, and along rights of way sixty (60) feet in width over and expect the lands in Skamania and Cowlitz Counties, Washington, described on the naturated "Exhibit A," being thirty (30) feet on each side of the centerline of a soul or roads located approximately as shown in green on the attacked "Exhibit B." Expect as to said lands to all matters of public record.

The parties hereto hereby agree that the rights hereinabove granted by one purity hereto to the other shall be subject to the following terms and conditions:

1. The easements are conveyed for the purpose of construction, reconconstitut, use and maintenance of a road or roads for the purpose of hauling forest purchase and other valuable materials from lands now owned or hereafter acquired by and contries hereto, and to provide access to said lands for land management and committative activities.

Provided, however, thirty (30) days prior to any construction, transferentian, and/or betterment of said roads by either party on lands If the other party, the initiating party will submit to the landowning party a wratten request for joint review of the proposed project, upon completion of which the initiating party will submit a complete and detailed plan of operations. Each party's operations, specified herein shall be conducted to accordance with the provisions of the approved plan of operations. Said printing shall provide the other party the right of examination of the right of before any construction, reconstruction, or development is commenced.

- 2. Each party hereto reserves for itself, its successors and assigns, the right at all times for any purpose, to cross and recross at any place on grade or calcavion on its own lands, and to use said rights of way in a manner that will car carcasonably interfere with the rights granted herein.
- 3. Each party hereto may grant to third parties, upon such terms as It chance, on its own lands, any or all of the rights reserved by it herein; case agreement and shall not unressonably interfere with the rights granted to the other party herein.
- 4. Each party hereto may permit its respective agents, contractors, litermine, lessees, parchasers of timber or other valuable materials, and their agents,
 lessees, parchasers to an "Fermittee" and collectively referred to as

- 5. The cost of road maintenance and resurfacing shall be allocated on the basis of respective uses of said roads. When any party uses a road, that party shall perform or cause to be performed, or contribute or cause to be contributed, that share of maintenance and resurfacing occasioned by such use as hereinafter provided. During periods when a road is being used solely by one party, such party shall maintain that portion of said road so used to the standards existing at the time use is commenced. During periods when more than one party is using the same road, or any portion thereof, the parties hereto shall meet and establish necessary maintenance provisions. Such provisions shall include, but shall not be limited to:
- (a) The appointment of a maintainer, which may be one of the parties hereto or any third party, who will perform or cause to be performed at a reasonable and agreed upon rate the maintenance and resurincing of the road or the portion thereof being used; and

(b) A method of payment by which each party using said road or a portion thereof, shall pay its pro rate share of the cost incurred by said maintainer in maintaining or resurfacing said road or portion thereof.

For purposes of this agreement, maintenance is defined as the next normally necessary to preserve and keep the roadway, road structure are read facilities as nearly as possible in their present condition or as fer in the improved.

- 6. Each party using any portion of a road shall repair, or cause to be repaired, at its sole cost and expense, that damage to said road sceasioned by it which is in excess of that which it would cause through normal and prudent usage of said road. Should inordinate damage to a road occur which is not caused by an authorized user of said road, the parties hereto shall meet to agree upon the cost of replacement, the party to undertake the replacement, and the shares of replacement cost to be borne by each user of said road.
- 7. Unless the parties hereto agree in writing to share the costs of improvements in advance of such improvements being made, such improvements shall be solely for the account of the improver.
- 8. Each party hereto reserves to itself c11 timber now on or hereafter growing within the rights of way on its said lands.
- 9. Each party hereto shall require each of its Permittees, before using any of said roads on the lands of the other party hereto for commercial purposes, to:

 (a) Obtain and during the term of such use, maintain a policy of liability insurance in a form generally acceptable in the trade and customary in the area of said rights of way, insuring said Permittee against Hability arising our of its operations, including use of vehicles. Minimum amounts of insurence shall be:
- (1) For log haulers, and other miscellaneous users operating heavy trucks (over one (1) "o..), Two Hundred Fifty Thousand Dollars (\$250,000.00) for injury to one person, Five Hundred Thousand Dollars (\$500,000.00) for any one occurrence, and Two Hundred Fifty Thousand Dollars (\$250,000.00) property damage for any one occurrence;
- (2) For fern cutters, bough cutters, shake cutters, or other miscellaneous users operating pickup trucks, light trucks (under one (1) ton) or passenger cars for the purpose of transporting miscellaneous forest products, One Hundred Thousand Dollars (\$100,000.00) for injury to one person, Three Hundred Thousand Dollars (\$300,000.00) for any one occurrence, and One Hundred Thousand Dollars (\$100,000.00) property damage for any one occurrence; or

(3) Such other limits as the parties hereto may agree upon in writing from time to time.

(b) Deliver to each party hereto a certificate from the insurer of said Permittee certifying that coverage in not less than the above named amounts is in force and that, in the event of cancellation or modification of such coverage, the insurer will give each party hereto ten (10) days written notice prior to any cancellation or modification.
