

PURCHASER'S ASSIGNMENT OF CONTRACT AND DEED

the following described real estate, situated in the County of Skamania

State of Washington, including any interest therein which grantor may hereafter acquire: That portion of Government Lots 3 and 4 in Section 2, Township 3 North, Range 10 East, W.M., Skamania County, Washington, more particularly described as follows:

Commencing at the Northwest corner of said Government Lot 4; thence south 03° 09' 33" East along the West line of said Government Lot 4, 1268.89 feet to the Southwest corner of said Government Lot 4; thence North 89° 09' 21" East along the South line of said Government Lot 4, 1133.73 feet; thence leaving said South line at right angles North 0° 50' 39" West 60 feet to an iron rod and the point of beginning of this description; thence North 38° 17' 13" East 134.28 feet; thence North 29° 30' 33" East 142.68 feet to an iron rod; thence North 31° 03' 33" West 170.06 feet to an iron rod; thence North 07° 27' 06" West 150.61 feet; thence North 17° 06' 41" West 662 feet to an iron rod, said point being on the North line of said Government Lot 4; thence North 88° 32' 00" East along the North line of said Government Lot 4 and along the North line of Government Lot 3 of said Section 2, 491.30 feet to a point North 02° 08' West from the Northwest corner of a tract of land conveyed to Bernard C. 
