

A right of way as required for the County road known and designated as Mt. Pleasant Road, County Road No. 11030, located in the Northwest quarter (NW $\frac{1}{4}$ ) of Section 9, Township 1 North, Range 5 East W.M.

CENTERLINE DESCRIPTION

Beginning at the brass monument marking the West quarter corner of Section 9, Township 1 North, Range 5 East W.M. Thence N 58° 14' 46" E 2,073.27 feet to P.C. Station 62 + 99.98, being the initial point of the centerline herein described and being the P.C. of a 300 foot radius curve to the right. The long chord of which bears S 48° 48' 19" W; thence along said curve to the right through a central angle of 29° 53' 50" 156.54 feet; thence S 63° 45' 15" W 16.64 feet to P.C. Station 64 + 73.17, being the P.C. of a 700 foot radius curve to the left. Thence following said curve to the left through a central angle of 23° 36' 31" 288.43 feet; thence S 40° 08' 44" W 256.91 feet to P.C. 70 + 18.51, being the P.C. of a 600 foot radius curve to the left. Thence following said curve through a central angle of 7° 38' 13" 79.97 feet; thence S 32° 30' 31" W 174.85 feet to P.C. Station 72 + 73.33, being the P.C. of a 350 foot radius curve to the right. Thence following said curve through a central angle of 50° 55' 37" 311.09 feet to P.T. Station 75 + 84.43, said P.T. Station lying N 67° 17' 36" E 850.31 feet from the brass monument marking the west quarter corner of Section 9, Township 1 North, Range 5 East W.M.

RIGHT OF WAY DESCRIPTION

That portion of the Northwest quarter (NW $\frac{1}{4}$ ) of Section 9, Township 1 North, Range 5 East W.M. lying southerly of the Mt. Pleasant Road as existing in March, 1978 and northerly from a line drawn as follows: Beginning at a point 40 feet left from P.T. Station 64 + 56.53 on the above described centerline; thence parallel to and 40 feet left of said centerline to Station 65 + 00; thence to a point 30 feet distant left from Station 66 + 00; thence parallel to and 30 feet left of said centerline to Station 74 + 00. Only that portion of the above described right of way falling within the Grantors property.

Containing a total area of 0.57 acres  
and being a net additional right of way  
of 0.32 acres more or less.
