 situated in the County of Skamania, State of Washington, to wit:

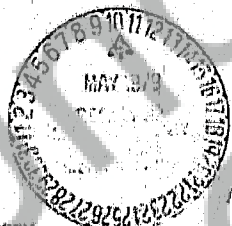
Lot 23 , Block 8 , Plat of Relocated North Bonneville recorded in

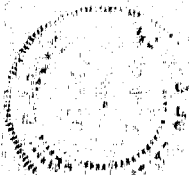
