



STATUTORY WARRANT DEED

THE GRANTOR, FIRST INDEPENDENT BANK, Trustee for EUGENE F. LACKEY and F. PEARL LACKEY, husband and wife, for and in consideration of Ten Dollars and other valuable consideration, in hand paid, convey's and warrants to ROBERT F. DISDIER and JEANETTE B. DISDIER, husband and wife, the following described real estate situated in the County of Skamania, State of Washington:



BEGINNING at a point on the South line of Section 31, Township 2 North, Range 6 E.W.M., said point being 630 feet East of the Southwest corner of said Section 31; thence North parallel to the West line of said section 563 feet, more or less, to the center of an existing gravel road; thence Eastwardly along the center of said road 770 feet, more or less, to a point 1320 feet East of the West line of said Section 31; thence South parallel to the West line of said section 514 feet, more or less, to the South line of said section, thence West along said South line 690 feet to the point of beginning; containing 6.8 acres, more or less.

ALSO, the East 690 feet of the West 1320 feet of the North 835 feet of the Northwest quarter of Section 6, Township 1 North, Range 6 E.W.M., containing 15.2 acres, more or less.

TOGETHER WITH an easement 30 feet in width, for road and utility purposes from subject property to Smith-Cripe Road.

This deed is given in fulfillment of that certain real estate contract between DEAN VOGT and LOIS VOGT, husband and wife and WILLIAM PROKSEL and LUCILLE PROKSEL, husband and wife, as Sellers, and the above-named grantees, as Purchasers. The interest of WILLIAM PROKSEL and LUCILLE PROKSEL was transferred to DEAN VOGT and LOIS VOGT, husband and wife, by Seller's Assignment of Real Estate Contract dated September 28, 1972. The interest of DEAN VOGT and LOIS VOGT, husband and wife, in said contract was assigned to EUGENE F. LACKEY and F. PEARL LACKEY, husband and wife, by Deed and Seller's Assignment of Real Estate Contract dated October 5, 1972, and recorded as Document No. 75498, on November 9, 1972, in Book 64, of Deeds, at Page 694. The interest of EUGENE F. LACKEY and F. PEARL LACKEY was assigned to Grantor above-named by Deed and Seller's Assignment of Real Estate Contract dated September 12, 1975, and was recorded November 24, 1975, as Document No. 81430, in Book 70, of Deeds, Page 45.
