

CORRECTION DEED

In hand paid, conveys and warrants to DUANE B. BERRY and INEZ J. BERRY, husband and wife,
and MICHAEL H. RIKE and CAROL A. RIKE, husband and wife,
the following described real estate, situated in the County of Skamania, State of Washington:

A tract of land in the Jos. L. Robbins D. L. C. being more particularly described as follows:

Beginning at the northeast corner of a tract of land conveyed to Konrad Hauser and Ora J. Hauser, husband and wife, by deed dated December 3, 1964, and recorded at page 385 of Book 53 of Deeds, Records of Skamania County, Washington; thence north 65° 07' 15" west 150 feet; thence north 00° 42' 58" east 280 feet; thence south 45° 27' 54" east 275.24 feet; thence south 08° 10' 12" west 170.07 feet; thence north 65° 07' 15" west 43.48 feet to the point of beginning; said tract being as surveyed and monumented by Dennis L. Wallace, professional land surveyor;

TOGETHER WITH an easement and right of way for a water pipeline not exceeding an inch and one-half in diameter and the right to take water from the existing water system for domestic purposes only for not more than two single unit dwelling houses;

RESERVING and EXCEPTING to the grantors, their heirs and assigns, an easement over the existing access road along the easterly line of said tract, said easement being approximately 40 feet in width on the south and diminishing to 10 feet on the north.
