

EASEMENT AMENDMENT

THIS EASEMENT AND AMENDMENT is made and entered into this 6th day of July, 19 79, by and between the STATE OF WASHINGTON acting by and through the Department of Natural Resources, herein called the "State," and ELIZABETH BOND STARKER, herein called "Starker," with reference to the following facts:

A. On January 3, 1977, Starker and the State entered into a certain Easement which was recorded in the records of Skamania County under Auditor's File No. 83497 in Volume 72 of Deeds, Pages 185 thru 189.

B. The State and Starker desire hereby to amend the Easement so as to delete a certain road therefrom and add a certain road thereto.

NOW THEREFORE, the State and Starker mutually agree as follows:

1. There is hereby deleted from the Easement above described that certain road as shown in blue on the attached Exhibit A, over and across portions of the NE 1/4 SE 1/4, Section 16, Township 2 North, Range 7 East, W.M., in Skamania County, Washington.

2. There is hereby added to the Easement above described that certain road as shown in red on the attached Exhibit A, over and across portions of the SW 1/4 NE 1/4, N 1/2 SE 1/4, Section 16, Township 2 North, Range 7 East, W.M., in Skamania County, Washington.

3. State shall make a payment of \$15,568.00 to K. W. Peterson, licensee of Elizabeth Bond Starker, for the rights granted to State by Elizabeth Bond Starker under this easement amendment.

4. Except as herein expressly amended, the Original Easement is hereby confirmed and ratified and remains in full force and effect.

TOWNSHIP 2 NORTH, RANGE 7 E. W.M.

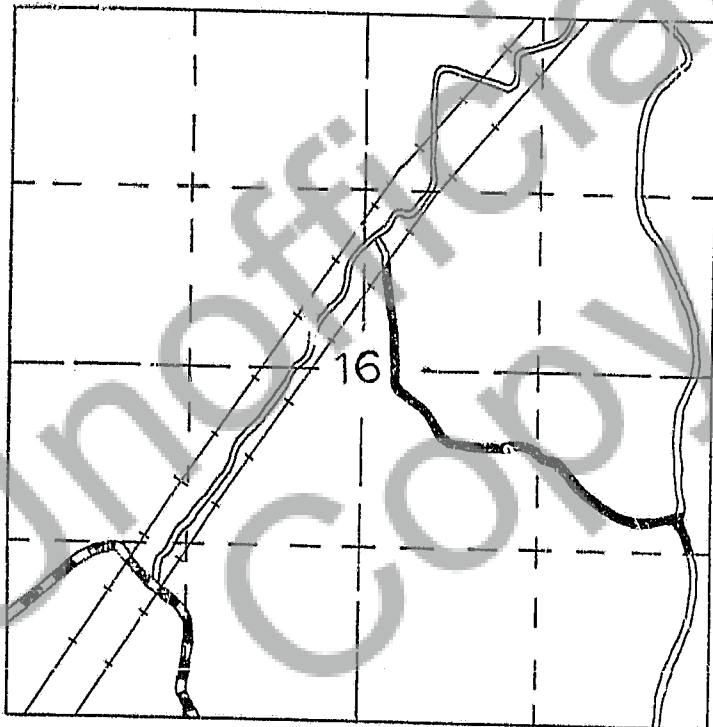
