QUITCLAIM DEED

Beginning at the North quarter corner of Section 20, Township 3 North, Range 8 East of the W.M., Skamania County, thence South along the center Section Line 1122 feet to the point of beginning; thence West 396 feet; thence South 330 feet; thence East 396 feet; thence North 330 feet to the point of beginning.

TOGETHER WITH a 30-foot easement for ingress and egress over and across the North half of the Northwest quarter of Section 20, Township 3 North, Range 8 East, W.M.

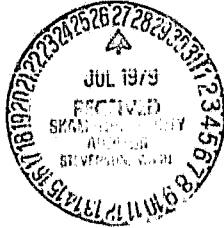
