

QUITCLAIM DEED

Beginning at the North quarter corner of Section 20, Township 3 North, Range 8 East of the W.M., Skamania County, thence South along the center Section Line 792 feet to the point of beginning; thence West 396 feet; thence South 330 feet; thence East 396 feet; thence North 330 feet to the point of beginning.

TOGETHER WITH a 30-foot easement for ingress and egress over and across the North half of the Northwest quarter of Section 20, Township 3 North, Range 8 East, W.M.

Together with all tenements and appurtenances belonging thereto, and remainders, reversions, rents, issues, and profits, to husband as his sole and separate property, free from obligations or marital rights of wife, and grants to husband all power to sell, transfer, or encumber the property.
