

E A S E M E N T

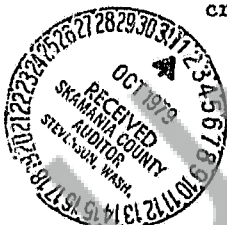
I, BERNICE M. BERGE, of M.P. 2.51 R Berge Road, Stevenson, County of Skamania, State of Washington, in consideration of the mutual and prospective benefits to be derived by reason of the locating, establishing, construction and maintaining certain water works, sewers, electric light lines and other related activities authorized by law, do hereby convey and release to Home Valley Water District, County of Skamania, State of Washington and its heirs, successors, or assigns, an easement for a certain water line, hereinafter more particularly designated and described, over and across lands owned by me and situated in the County of Skamania, State of Washington and more particularly described as follows:

An easement for roadway and utilities in Skamania County, Washington, over and across the N 1/2 of the SW 1/4 of Section 23, T.3N., R.8E., W.M. being 40 feet in width, 20 feet on either side of the following described centerline.

BEGINNING at a point 228 feet West along the center of section line from the iron pipe at the center of said Section 23; thence Southerly parallel with and 228 feet Westerly of the North-South centerline of Section 23 to the centerline of the County road known as Bylin Road.

The length of easement is 100 feet, more or less and contains 0.09 acres more or less.

The easement hereby conveyed and released is for the sole purpose of locating, establishing, construction and maintaining over and across the above-described land a certain water line, sewer lines electric light lines and other related activities authorized by law, petition for which was made in writing to the Board of County Commissioners of Skamania County, Washington on July 30, 1979, by Home Valley Water District and the need for such as been determined by the Board of County Commissioners of Skamania County.
