EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 18th day of September 1979, by and between CROWN ZELLERBACH CORPORATION, a Nevada corporation, herein called "Crown," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 24th day of August, 1972, Crown and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington, on the 8th day of November, 1972, in Volume 6 of Deeds, pages 577 through 586 under Auditor's File No. 75490. Said Original Easement is hereby supplemented as follows:

A. Crown for and in consideration of Three Hundred and No/100 Dollars (\$300.00) hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across portions of the NE 1/4 NW 1/4 of Section 24, Township 3 North, Range 7 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road or roads located approximately as shown in red on the attached "Exhibit A."

Subject as said lands to all matters of public record.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.

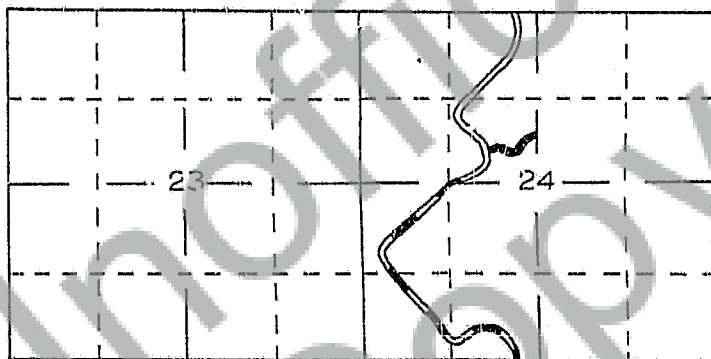
