convey and quit claim to ALBERTINA KERR CENTER FOR CHILDREN,

the following described real estate, situated in the County of Skamania,
State of Washington, including any after acquired title:

That portion of the Southwest quarter of Section 29, Township 2
North, Range 5 East of the Willamette Meridian, in Skamania County,
Washington, described as follows:

Beginning on the Westerly line of Skye-Bear Prairie Road that is
860 feet Northerly, as measured along said Westerly line, from the
intersection of said Westerly line with the South line of the said
Southwest quarter of Section 29; thence Southerly along the Westerly
line of Skye-Bear Prairie Road, 860 feet to the South line of
Section 29; thence West along the South line of the Southwest
quarter of Section 29, a distance of 1015 feet to the Southwest


