STATUTORY WARRANTY DEED

THE GRANTOR, FIRST INDEPENDENT BANK, Trustee for EUGENE F. LACKY and F. PEARL LACKY, husband and wife, for and in consideration of Ten Dollars and other valuable consideration, in hand made, conveys and warrants to JAY T. JACOBSON and ALEXIA A. JACOBSON, husband and wife, the following described real estate, situated in the county of Skamania, State of Washington:

The Southeast quarter of the Northeast quarter of the Southwest quarter (SET NE¹ SW¹) of Section 31, Township 2 North, Range 6 N.W.M.;

EXCEPT that portion thereof described as follows:

BEGINNING AT a point 660 feet South of the center of the said Section 31; this point being the Southeast corner of a 20 acre tract; thence South 214 feet; thence North 31°27' West 205.1 feet to the South line of the 20 acre tract; thence East 150 feet to the point of beginning containing 32/100 acre, more or less;

AND EXCEPT that portion thereof lying Northwesterly of County Road 1009 designated as the Smith-Crider Road.
