

PARTIAL RELINQUISHMENT

WHEREAS, by that certain Right of Way Contract dated January 23, 1956, recorded in the Records of Skamania County, Washington, in Book 41, Pages 157-161, Longview Fibre Company, granted and conveyed unto Pacific Northwest Pipeline Corporation, a Delaware corporation, its successors and assigns, a right of way and easement located in, under and through the following lands situated in Skamania County, Washington, to wit:

Township 2 North, Range 7 East, W.M.
Section 19: SE $\frac{1}{4}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$; and

WHEREAS, ownership of the above described property is now vested in Longview Fibre Company, hereinafter referred to as Grantee; and

WHEREAS, Northwest Pipeline Corporation, a Delaware corporation, hereinafter referred to as Grantor, is the successor in interest to Pacific Northwest Pipeline Corporation; and

WHEREAS, Grantor and Grantee mutually desire that a portion of said right of way and easement be relinquished.

NOW THEREFORE, for and in consideration of TEN DOLLARS (\$10.00) and other good valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Northwest Pipeline Corporation does hereby relinquish, quitclaim, and for or discharge unto Longview Fibre Company, its heirs, successors and assigns, all rights acquired through the above cited Right of Way Contract as they affect the following described property:

Skamania County, Washington
Township 2 North, Range 7 East, W.M.
Beginning at a point on the East Boundary of Section 19, said point being 2381 feet southerly of the Northeast corner of said Section 19, thence S. 60° 30' W. a distance 748.3 feet, more or less, to a point on the existing Ignacio to Sumas Line, located in the Southeast quarter of the Northeast quarter of Section 19, said point bearing S. 12° 54' W. a distance of 2796.5 feet from the Northeast corner of said Section 19,

together with all interest, right and title thereto.

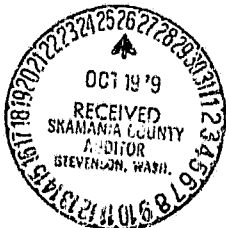
