Also described as Lot 1 of the Laird Short Plat as recorded in Book 2, page 104 of Skamania County Short Plat Records.

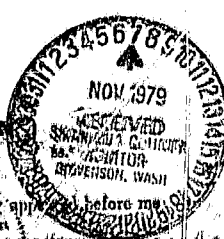
