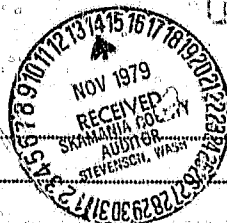

the following described real estate, situated in the County of Skamania, State of Washington:

A portion of the Northeast quarter of the Northwest quarter of Section 8, and a East half of the East half of the Northwest quarter of the Northwest quarter, of Section 8, Township 1 North, Range 5 East of the Willamette Meridian, more particularly described as follows:
