

EASEMENT

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the Grantors, MEL E. STUART and VERNAL M. STEWART, husband and wife, hereby grant and convey to the Grantees, GEORGE F. CHRISTENSEN, JR. and ANN CHRISTENSEN, husband and wife, and ROBERT K. LEICK and CLAUDIA J. LEICK, husband and wife, their successors and assigns, an easement for ingress, egress, and utilities, 60 feet in width, lying 30 feet to each side of the following described centerline:

A portion of the Northwest quarter of Section 25, Township 3 North, Range 7 E.W.M., Skamania County, Washington, described as follows:

BEGINNING at the Northwest corner of the South Half of the Northwest quarter of the Northwest quarter of said Section 25; thence South $38^{\circ} 45' 54''$ East along the North line thereof, 768.00 feet to a 1/2 inch iron rod; THENCE South $16^{\circ} 43' 38''$ East, 254.58 feet to a 1/2 inch iron rod; THENCE South $02^{\circ} 22' 15''$ East, 162.12 feet to a 1/2 inch iron rod; THENCE South $22^{\circ} 01' 41''$ West, 95.61 feet; THENCE South $22^{\circ} 01' 41''$ West, 98.38 feet to a 1/2 inch iron rod; THENCE South $20^{\circ} 14' 10''$ West, 175.45 feet to a 1/2 inch iron rod; THENCE South $24^{\circ} 35' 20''$ West, 105.22 feet to a 1/2 inch iron rod; THENCE South $24^{\circ} 05' 57''$ West, 105.63 feet to the North right-of-way line of a 50 foot radius cul-de-sac at the terminus of Maple Hill Road as shown on the plat of "Maple Hill Tracts No. 3"; THENCE South $37^{\circ} 43' 50''$ East, 50.00 feet to the center of said cul-de-sac and the TRUE POINT OF BEGINNING of this centerline description; THENCE South $48^{\circ} 20' 00''$ West along said centerline 325.64 feet; THENCE along the arc of a 200 foot radius curve to the right, for an arc distance of 194 1/2 feet; THENCE South $78^{\circ} 20' 00''$ West, 178.36 feet; THENCE along the arc of a 50 foot radius curve to the right, for an arc distance of 70.00 feet to the terminus of said centerline description. Said point bears North $89^{\circ} 00' (0)$ West, 103.74 feet from a point on the West line of the Northwest quarter of Section 25 which is North $00^{\circ} 34' 36''$ East, 713.65 feet from a Skamania County brass cap at the West quarter corner of Section 25.

EXCEPT County Roads.

In exercising the rights herein granted, the Grantees, their successors and assigns, may pass and repass over said land and may cut and remove brush, trees and other obstructions which in the opinion of the Grantees interfere with their easement rights.

The covenants herein contained shall run with the land and are

binding upon all subsequent owners thereof.
