hereinafter called the "purchaser,"

WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agrees to purchase of the

seller the following described real estate with the appurtenance, situate in Washington:

The East Half of the Northeast Quarter of the Northeast Quarter of the Southeast Quarter (Elg NEW NEW SEW) of Section 32, Township 2 North, Kange 6 E. W. M., TOGETHER WITH a non-exclusive vasement and right of way 30 feet in width for access over the existing road connecting with County Road No. 1010 designated us the Franz Road; EACEPT that portion thereof lying Within and southerly of County Road No. 1010 designated as the Franz Road.

Free of incumbrances, except. an easement and right of way 30 feet in width over and across an existing road on said premises reserved by sellers, their heirs and assigns, for access and utilities appurtenant to other real property owned by the grantors.

On the following terms and conditions: The purchase price is SEVEN THOUSAND FIVE HUNDRED and (\$ 7,500.00 $K_{\perp}V_{\perp}$ - (\$ 500.00 📥) dollars FILE HUNDRED and NO/100 has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said parchase price as follows:

The purchasers agree to pay the balance of the purchase price in the 5 m of Seven Thousand and No/100 (\$7,000.00) Dollars in monthly installments of Fifty and No/100 (\$50.00) Dollars, or more, commencing on the first day of February, 1975, and on the first day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of eight percent (8/1) per annum computed upon the monthly balances of the unpaid purchase price and shall be applied first to interest and then to principal. The purchasers reserve the right any time they are not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest, then due.

The purchaser may enter into possession January 1, 1975.

The property has been carefully inspected by the putchase, and no agreements or representations pertaining thereto, or to this transaction, have been made, take such as are stated herein.

The purchaser agrees: to pay before delinquency all taxes and assessments assumed by him, if any, and The purchaser agrees: to pay before definitioned at taxes and assessments assumed by him, it any, and any which may, as between grantor and grantee, hereafter become a litto in, the premises; not to permit waster and not to use the reconses for any illegal purpose. If the purchaser shall fail to pay before delinquency any such taxes or assessments, the seller may pay them, and the amounts so paid shall be decaded part of the purchase price and be payable forthwith with interest at the rate of ten per cent per annum until paid, without prejudice to any other right of the seller by reason of such failure.

The purchaser assumes all risk of the taking of any part of the property for a public use, and agree, that any such taking shall not constitute a failure of consideration, but all moneys received by the seller by reason thereof shall be applied as a payment on account of the purchase price, less any sams which the seller may be required to expens in procuring such moneys.

If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation, which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.

The solier agrees, upon full compliance by the purchaser with his agreements berein, to execute and

deed to the property, excepting any part deliver to the purchaser a Warranky which may have been condemned, free of incombrances except those above mentioner, and any that may accrue hereafter through any person other than the seller-

The seller agrees to furnish a Transumerica little insurance Company standard form purchaser's title policy when the purchaser shall have paid the purchase price in full.
insuring the title to said property with sability the same as the above purchase price, free from incumbrances except any which are assumed by the purchaser or as to which the conveyance hereunder is not to be subject.

Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any condition or agreement hereon promptly at the time and in the manner herein required, the seller may elect to declare all of the purchaser's rights hereunder terminated. Upon the termination of the purchaser's rights, all payments made hereunder, and all improvements placed upon the premises shall be forfeited to the seller as liquidated damages, and the seller shall have the right to re-enter and take possession of the property; and if the seller after such forfe't are shall romatence an action to procure an adjudication of the termination of the purchaser's rights hereunder, the purchaser agrees to pay the expense of searching the title for the purpose of such action, together with all costs and a reasonable attorney's fee.

Service upon purchaser of all demands, notices or other papers with respect to forfeiture and termination of purchaser's rights may be made by United States Mail, postage pre-paid, return receipt requested, directed to the purchaser at his address last known to the seller.
