This quit claim deed, made January 30, 1980, by BELLE GEORGIA ERICKSON, a widow, of Home Valley, County of Skamania, State of Washington, to JOE PALERMO and BERTHA PALERMO, husband and wife, of White Salmon, County of Klickitat, State of Washington, witnesseth:

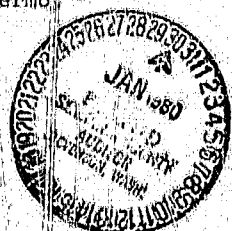
That Belle Georgia Erickson, in consideration of Ten Dollars (\$10.00) to her paid, the receipt of which is acknowledged, does by these presents forever quit claim unto Joe Palermo and Bertha Palermo, husband and wife, all of the interest of Belle Georgia Erickson, if any, in and to that certain lot of standing timber located in the County of Skamania, and State of Washington, and more certainly described as follows:

A tract of land located in Section 26, Township 3 North, Range 8 East of the Willamette Meridian, situate in the County of Skamania, State of Washington, more particularly described as follows:

Beginning at a point 1265 feet West of the South Quarter corner of Section 26,; thence North 480 feet; thence East 145 feet; thence North 148 feet; thence East 485 feet; thence South 410 East 130 feet; thence South 30° 52' West 105 feet; thence South 120° 41' West 93 feet; thence South 10° 23' East 187 feet; thence West to the Westerly line of Wind Mountain Road; thence Southerly to section line; thence West 380 feet to the point of beginning.

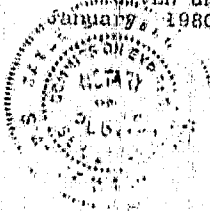
