SMITH and PATRICIA J. SMITH, husband and wife, as Grantee, the following described real estate, situated in the County of Skamania, State of Washington:

Beginning at a point on the South Boundary line of Second Street in the Town of Stevenson, which is South 600 feet and North 89°14' West 463 feet from the intersection of the West line of the Henry Shepard D.L.C., and the North line of Section 1, Township 2 North, Range 7 E. W. M.; thence south 159 feet; thence south 39° 14' East 50 feet; thence North 159 feet to the South boundary line of Second Street; thence West following the South boundary line of Second Street 50 feet to the point of beginning.

TOGETHER WITH and SUMJECT TO an easement for the use in common with the adjoining landowner of the existing driveway along the westerly line of the above-described real property.
