RIGHT OF WAY EASEMENT

THE GRANTOR(S) DAVID L. ALLEN AND DEBORAH K. ALLEN, husband and wife

for good and valuable consideration, the receipt of which is hereby acknowledged, hereby grant, warrant and convey to PUBLIC UTILITY DISTRICT NO. 1 OF SKAMANIA COUNTY, WASHINGTON, a municipal corporation, and to its successors and sub-lessee or assigns, the right to enter upon the lands of the Grantor(s) situated in the County of Skamania, State of Washington, and more particularly described by the following easement: A strip of land 5 feet in width and 105 feet in length from the existing transformer to the county road known as Old State Road. Said easement being located in the following described property:

A tract of land in the South Half of the Southeast Quarter of the Northeast Quarter (Section 1); and the East Half of the Northeast Quarter of the Southeast Quarter (E.N.E. Quarter); all in Section 1, Township 3 North, Range 7½ E.W.M., all lying within Skamania County, State of Washington; more particularly described as follows:

Beginning at the east quarter corner of said Section 1; thence north 44° 36' east a distance of 398.80 feet; thence north 88° 30' 40" west a distance of 648.65 feet; thence south 00° 36' 22" west a distance of 42.54 feet; thence south 40° 01' 45" east a distance of 993.88 feet; thence north 00° 30' 30" east a distance of 387.98 feet to the true point of beginning, EXCEPT that portion of said tract lying within the right of way for Old State Highway.

To construct, operate and maintain over and under the above described lands, and the streets, roads or highways abutting the said lands, an underground electric transmission or distribution line or system, including wires and conduit, with all convenient or necessary surface mounted appurtenances (and to include river poles and transformer poles when required) and to cut and trim trees and shrubbery that may interfere with or endanger the operation and maintenance of said line or system, and to license, permit or otherwise agree to the joint use or occupancy of said line or system by other person, firm or corporation for telephone or television purposes.

The grantor(s) agree(s) that all poles, wires or other facilities installed upon or under the above described lands at the Grantor's expense shall remain the property of the Grantee, and that the Grantee shall have the right of ingress and egress over the adjacent lands of the Grantor(s) for the purpose of exercising the rights hereby granted.

All rights hereunder shall cease when the Grantee, its successors and sub-lessee or assigns abandons or removes said line or system.


