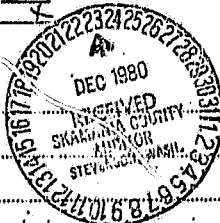

 for and in consideration of the sum of Ten Dollars and other valuable considerations  
 (\$ 10.00 ) Dollars, to us in hand paid, and in further consideration of the general public  
 welfare, do by these presents grant, convey and dedicate to Skamania County,  
 State of Washington, for the use of the public as a county road and appurtenances the following de-  
 scribed real property in the County of Skamania State of Washington:

A right of way as required for Cottonwood Street, County Road No. 30410,  
 located in Sections 26 & 27, Township 3 North; Range 8 East, W.M. in Skamania  
 County, Washington.

more particularly:

That right of way being 30 feet on each side of the following described  
 centerline and also including a circle being of 50 feet radius centered on  
 Station 12+23.76.

## Centerline Description

Beginning at Station 0+00, said point being 308.06 feet East and 722.44 feet  
 North of the Southwest corner of Section 26, Township 3 North, Range 8 East, W.M.;  
 thence N 73°56'30" W 520.00 feet to the P.C. of a 375.64 feet radius curve to the  
 right a distance of 137.56 feet to the P.T.; thence N 43°48'30" N 159.30 feet to  
 the P.C. of a 622.91 feet radius curve to the right a distance at 237.55 feet to  
 the P.T.; thence N 21°56'30" W 109.35 to the center of the Turnaround Station 12+23.76.
