(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public

welfare, do by these presents grant, convey and dedicate to Skamania County,

State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of Skamania State of Washington:

A right of way as required for Erickson Road, County Road No. 32260, located in Section 26, Township 3 North; Range 8 East W.M. in Skamania County, Washington.

More particularly:

That right of way being 30 feet on the left side of the following described Erickson Road centerline and 30 feet on the right side from the Point of Beginning to the P.C. 357.96 feet distance along the centerline from the Point of Beginning; thence continuing on the right side with 30 feet and decreasing to 0 feet at approximately 460 feet distance along the centerline from the Point of Beginning.

Centerline Description

Beginning at the Point of Beginning, said point being 792.99 feet East and 519.63 feet North of the Southwest corner of Section 26, Township 3 North, Range 8 East W.M., thence N 81°39'32" W 357.96 feet to the P.C., thence on a 156.76 feet radius curve to the right 220.59 feet to the P.T., thence N 01°02' W 11.92 feet.
