the following described real estate, situated in the County of Skamania State of Washington:



THAT PORTION OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 7 EAST OF THE WILLAMETTE MERIDIAN, IN SKAMANIA COUNTY, STATE OF WASHINGTON, DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID NORTHWEST QUARTER OF THE SOUTHWEST QUARTER; THENCE SOUTH ALONG THE WEST LINE THEREOF TO A POINT 20 FEET SOUTH OF THE SOUTH BANK OF ROCK CREEK; THENCE EASTERLY AND SOUTHERLY ON A LINE PARALLEL WITH AND 20 FEET SOUTHERLY FROM SAID SOUTH BANK TO THE SOUTH LINE OF SAID NORTHWEST QUARTER OF THE SOUTHWEST QUARTER; THENCE EAST, ALONG SAID SOUTH LINE TO THE MIDDLE OF ROCK CREEK; THENCE NORTHERLY AND WESTERLY FOLLOWING THE MIDDLE OF SAID CREEK TO ITS INTERSECTION WITH A LINE DRAWN PARALLEL WITH AND DISTANT 330 FEET FROM THE EAST LINE OF SAID NORTHWEST QUARTER OF THE SOUTHWEST QUARTER; THENCE NORTH TO THE NORTH LINE OF SAID NORTHWEST QUARTER OF THE SOUTHWEST QUARTER; THENCE WEST, ALONG SAID NORTH LINE 990 FEET MORE OR LESS, TO THE POINT OF BEGINNING.
