

DEDICATION DEED.

GRANTOR(S) Roy Dudley and Clara Dudley, Husband & Wifefor and in consideration of the sum of Ten Dollars and other valuable considerations(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general publicwelfare, do by these presents grant, convey and dedicate to Skamania County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of Skamania State of Washington:

A right of way as required for the County Road known and designated Wedrick Road, County Road No. 32720, located in the Joseph Robbins DLC #38 in Section 27, Township 3 North, Range 8 East W.M. in Skamania County Washington. More particularly:

A right of way 18 feet in width lying northerly of and contiguous to the following described line:

Beginning at a point on the west line of the Gunnar Johnson tract as described in deed recorded at Page 418, Book U of Deed, Records of Skamania County, Washington, said point lying North, 682 feet and East 660 feet from the intersection of the west line of the Jos. Robbins DLC #38 with the south line of Section 27, Township 3 North, Range 8 East W.M.; thence running East, parallel with the south line of said Section 27, 169.4 feet.
