COMMUNITY PROPERTY AGREEMENT

WE HEREBY MUTUALI AGREE that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature, and wheresoever situate, shall be and it is hereby declared to be community property, and each or the parties do hereby convey and transfer to the other and to their community, all such property hereafter acquired by either of them even though the same be

LAHAM, while the said BETTY A. LAHAM survives, be vested in BETTY A. LAHAM, absolutely and in fee simple as her sole and separate property; and, in the event of the death of the said BETTY A. LAHAM, while the said HENRY A. LAHAM survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said HENRY A. LAHAM, absolutely and in fee simple as his sole and separate property.
