## EXHIBIT A

A portion of the East half of the Southwest quarter of Section 30, Township 2 Worth, Range 5 East, Willamette Meridian, County of Skamania, State of Washington, described as follows:

BEGINNING at the center of said Section 30; thence along the North-South centerline of said Section South 01°02'58" Fast 957.04 feet; thence South 89°21'15" West 778 feet, more or less, to a point North 88°21'15" Fast 72' feet from the West line of the Fast half of the Southwest quarter of said Section; thence Southerly parallel with said that line and the said Section; thence Southerly parallel with said West line 625 feet to the TRUE POINT OF BEGINNING: thence from said true point of beginning and continuing Southerly parallel with said West line 200 feet, more or less, to a point on the North line of the LEWIS B. COLE Tract, as described in contract recorded April 18, 1979 in Book 76 of Deeds pages 398-400, records of said County; thence Easterly along said North line and the Easterly prolongation thereof, 786 feet, more or less, to a point on the East line of the Southwest quarter of said Section 204 feet North of the Northeast corner of the CLIFFORD B.
