A portion of the East half of the Southwest quarter of Section 30, Township 2 North, Range 5 East, Willamette Meridian, County of Skamania, State of Washington, described as follows:

BEGINNING at the center of said Section 30; thence along the North-South centerline of said Section South  $01^{\circ}02'58''$  East 957.04 feet; thence South  $89^{\circ}21'15''$  West 778 feet, more or less, to a point North  $89^{\circ}21'15''$  East 528 feet from the West line of the East half of the Southwest quarter of said Section; thence Southerly parallel with said West line 425 feet to the TRUE POINT OF BEGINNING; thence from said true point of beginning and continuing Southerly parallel with said West line 200 feet; thence Easterly to a point on the East line of the Southwest quarter of said Section located 425 feet South of the Southeast corner of the MERLE GENE FELLOWS Tract as described in contract recorded September 27, 1979 in Book 77 of Deeds at pages 253-255; records of said County; thence Northerly along said East line 200 feet; thence West to the TRUE POINT OF BEGINNING.
